### 2. PREMISES OF THE TRUST:



### 3. OBJECTS OF THE TRUST:


The main object of the trust are:-

4. To provide Hospital Facilities and Free Medical Camps to the poor and needful persons.




- ii. To function as a Non-Communal Trust and as secular organization.


**4. DECALATION OF TRUST :**

3. Without prejudice to the generality of the foregoing objects and purpose, but subject as aforesaid, it is declared that the Trustees shall each year apply the residue of the income of the Trust Funds, and may at their discretion at any time and from time to time apply also the Trust Funds or Object of the Trust.

**5. FUNDS OF THE TRUST:**

- a. The Funds of the Trust shall constitute the contribution of Rs.10,000 (Rupees Ten Thousand only) by the Founder Trustees.
- b. The trust is at liberty to receive contributions, Donations ,Gifts and such other types of funds given and contributed, donated by individuals, Bodies, Association, Companies, Institutions and Public at large.
- c. The property movable or immovable collected by the trust by transfer, taking over assignments, purchase, gift, donation, lease or any other type of contribution to in favour of the institution.
- d. The income of the institutions run and managed by the trust by way of contribution, donation, fees and other like income.
- e. The contribution of grant recurring and non-recurring of Government grants, State or Union Universities, Educational Boards, University Grants, Commission, Local authorities, Municipal bodies , Cultural, Educational Foundations and Associations, Companies, Industries and such other institutions and organizations.
- f. Such other income or resources or sources for the furtherance of the Objects of the Trust. Such other properties that are placed in the hands of the Trust for the purpose of sue and utilization for the benefit of the trust by way of entrustment or otherwise.


**7. MANAGING COMMITTEE**

Shall represent in all matters pertaining to the trust before the courts. Tribunals, Local authorities, Administrative tribunals, any offices Statutory , Administrative etc., and shall look after day to day affairs and management of all matters of the trust and it shall be accountable to the council of trustees.


Without prejudice to the general powers conferred by the proceedings, clause, it is hereby expressly declared that the managing committee shall also have the following specific powers and duties.


1. Shall be in overall and all general control and charge of all the institutions run, controlled and managed by the Trust.
2. Shall be responsible for due maintenance of all accounts and records of the trust in accordance with the rules that prevail in the place, in which the institution is constituted.
3. Shall be entitle to sign and endorse and authorize all negotiable instruments drawn in favour of anybody as may be required for the purpose of the trust.
4. Shall have the powers to receive the money payable by the state or other authorities of the state of central or international or any other body or associations and such other institutions to the Trust and give due discharge for the same.
5. Shall be entitled to appoint or remove all kinds of staff ministerial, professional, technical or otherwise the managing committee feels necessary for the efficient administration of the Trust and its institutions.

Shall entitle to raise finance for the purpose of the trust or the security of the Trust subject to the conditions that the funds so raised shall be utilized only for the purpose of the trust and not otherwise.







**13.VOTING :**

Decisions of the Board of Trustees may be made at a meeting or by circulation of paper to them .Normal matters of routine nature may be circulated and decision obtained. The important matters are to be decided at the meeting. All matters arising for disposal shall be decided by a majority of the Board of Trustees present at the Meeting. The President of the BOARD OF Trustees shall have a casting vote in the event of equality of votes, in addition to his own.

**14.POWERS AND DUTIES OF THE TRUSTEES:**

(a) All the property of the trust Movable or immovable or any other kinds, shall vest in trust. The Trustees shall manage the whole property and affairs of the trust and shall have all powers, duties and functions necessary proper and incidental to the promotion carrying out of the objects of the trust.

(b) In particular and without prejudice to the generality of the foregoing the Trustees shall for the purposes of this trust have the following powers, duties and functions:

- i. To acquire by gift, Grant, purchase, exchange lease, or otherwise, lands, building or other immovable properties and also any Movable Property.
- ii. To construct and maintain buildings, to alter, to demolish or improve them and equip them suitably.
- iii. To accept gift, donation, endowment and contribution for the trust and shall be treated as the income of the trust.
- iv. (a) To raise loans, to receive monies, securities or other movable property on behalf of the Trust.  
(b) To accept any trust, trust fund or endowment so long as the provision of such Trust or endowment is in consonance with the objects of this Trust.

- x. To appoint a Committee/ Committees of management for such terms and with such powers as may be specified from time to time , for carrying on the routine management of the affairs of the Trust.
- xi. To appoint such employees on such terms and conditions as the Trustees may deem fir for carrying out the work of the trust and exercise control all such employees including the power of suspension, dismissal and removal
- xii. To delegate to the Managing Trustee or any appointed committee such powers, duties and functions as are vested in the Trustees.
- xiii. To frame Bye-Laws and such other regulation as are required for achieving its objectives.
- xiv. Out of the income of trust property he trustee shall be entitled to spend or incur the following expenses namely.



- (i)All other costs, charges and expenses of and incidental to the management and administrative of the trust property in accordance with the objects and purpose hereof or which may be incidental thereto, After deducting the costs charges and expenses incurred by the trustee's as aforesaid out of the total gross income received by them from the trust property the balance that is the net income will be utilized for the object of the trust as decided by the board of trustees.

**15.THE COUNCIL OF TRUSTEES AND THEIR FUNCTION**

- a. Look after due and for official Administration, Supervision, and Management of all properties and institution of the Trust.
- b. Take all policy decision pertaining to the Trust.
- c. Elect managing committee to manage the institutions that are run by the Trust to suit the rules and regulations of the state or the authorities under whose control the institutions comes.



- e. Have the power to annul or modify or set aside any decision that will have been taken by the sub-committee & the decision shall bind the sub-committee.
- f. Have the power to raise funds on the security of the properties of the Trust to meet the needs of the trust and to meet the funds that may become necessary in due implementation of the schemes of the Trust.
- g. Consider and approve the accounts of the Trust periodically once in every year getting the scrutinized and audited by a Chartered Accountant.
- h. Meet at least once in a month
  - i. The trust may open Bank Account/s in the name of institution/ organization founded by the Trust. Such Bank Account shall be operated by such person as authorized by the board of trustees from time to time.

**16. OPERATION OF THE FUNDS AND BOOK OF ACCOUNTS:**

The funds of the trust shall be operated through an account in any Nationalized Bank or Commercial Banks jointly by the PRESIDENT and the SECRETARY.

- i. The Board of trustees may open such Bank Account or Accounts in any of the Banks in the name of either " RAJANNA CHARITABLE TRUST" OR "ASIAN PUBLIC SCHOOL ".Such accounts shall be jointly operated by the President and Managing Trustee.
- ii. The Trust may open Bank Account/s in the name of the institution/organization founded by the Trust such Bank Accounts shall be operated by such person as authorised by the Board of Trustees from time to time.


